BS 9997:2019

The introduction of the British Standards Institution (BSI) BS 9997:2019 – ‘Fire risk management systems standard (which supersedes and builds on the requirements of PAS 7:2013) presents requirements for an organisational fire risk management system (FRMS), providing the basis to build a resilient and robust management system.

The system can be applied in:

- Organisations that operate on multiple sites
- Separate management divisions within an organisation
- Individual premises within a single entity

It has been developed by BSI for use as a formal fire risk management system for organisations and individual sites and provides assurance to fire and rescue authorities when undertaking an audit for the Regulatory Reform (Fire Safety) Order 2005. It is designed to help demonstrate that the organisation is taking responsibility for managing fire risks and complying with the law.

It is designed to dovetail with the existing British Standard BS 9999 Code of Practice for fire safety in the design, management and use of buildings and other formal management systems such as the ISO 45001 health and safety management system. The specification applies the ‘plan, do, check, act’ model common to many business management systems.
